Over 1,400 cattle die of LSD as virus spreads to 20 districts



Ahmedabad: As many as 1,431 cattle died in Gujarat due to Lumpy Skin Disease (LSD) as the disease spread to 20 districts of the state, according to the state government.

The government has vaccinated 8.17 lakh cattle, formed a task force to counter the disease and imposed restrictions on movement of cattle in affected districts. LSD has been reported in 54,161 cattle in 1935 villages of 20 districts, including Kutch, Jamnagar, Devbhumi Dwarka, Rajkot, Porbandar, Morbi, Surendranagar, Amreli,

Bhavnagar, Botad, Junagadh, Gir Somnath, Banaskantha, Surat, Patan, Aravalli, Panchmahal, Mahisagar, Valsad and Mehsana. These 54,161 cattle have been treated, said Raghavji Patel, State Agriculture Minister. The government has imposed restrictions in organising cattle fairs and movement of cattle and in 14 of the affected districts. A formal notification has been issued by the government on July 26. The worst affected is Kutch district. "I will visit Kutch this Thursday to review the situation," said the minister adding that he has already visited Jamnagar, Devbhumi Dwarka, Junagadh and Rajkot.

A state level task force under the leadership of Nareesh Kelawala, vice-chancellor of Kamachenu University, has been constituted to provide appropriate advice and guidelines regarding vaccination and treatment of this disease. This task force will have five members.

The minister said that the government has received 21,026 calls on the free helpline number 1962 over the past eight days in connection with LSD. Patel said that the government has a stock of 7.9 lakh vaccine doses.

The nationwide drought is only making the woes of farmers and citizens wretched. The drought is taking place as a heat wave extends across much of India with temperatures crossing 40C for days now. Going by the figure, n 2021, a total of 432 catastrophic events were recorded, which is considerably higher than the average of 357 annual catastrophic events for 2001-2020. Floods dominated these events, with 223 occurrences, up from an average of 163 annual flood occurrences recorded across the 2001-2020 period. According to the Central Water Commission, water availability in India's 91 reservoirs is at its lowest in a decade, with stocks at a paltry 29% of their total storage capacity. Droughts

are among the greatest threats to sustainable development, especially in developing countries, but increasingly so in developed nations too. In fact, forecasts estimate that by 2050 droughts may affect over the quarters of the world's population.

India should wake up and authorities concern be a politician, bureaucrats or general public should understand the grave situation in store for us due to the fast change of climate. The greatest impact of a drought is seen on the weaker sections of society. These include landless labourers, small marginal farmers and artisans like weavers.

Over 55 crore farmers and rural populations across 13 States are in the grip of drought, and it is a multi-dimensional crisis. The 2016 drought is of richer and more water-guzzling India. Drought is a human-made crisis. The opposite of drought is continuing phenomenon, especially in the context of global warming. The ground water stored underground over hundreds of thousands of years was sucked out. This drought might not be the crisis this time as severe and calls for solutions that are more complex. One cannot say India cannot implement the measures like above to improve its water retention. The insensitivity on the part of Governments and the business class is appalling. It is heart-rending to read about people walking miles to get a small pot of water. Right from independence the problems of drought and flood management have remained unresolved. Around 400km from Mumbai, the region has been getting insufficient rains for the past three years. The shortage of power has forced the farmers to spend more on diesel consumption. On the other hand, crop

diversification needs to be advertised in a well-managed manner before acceptance. In the dries, slum dwellers have been badly affected because they cannot afford to buy water from private tankers. The money-lender charges high rate of interest and the inability of the farmer to repay the loan compelled them to forfeit their mortgaged property. In extreme cases, the farmers tend to commit suicide. Modern technologies should be implemented on farm. Water storage should be given top priority. If weather forecasts information is available beforehand, the farmer, they can be trained to
